- 1. DEVELOPMENT VARIANCE PERMITS & OTHER PERMITS, LICENCES & AGREEMENTS
- 1.1 Mutual Aid Agreement for Fire Service Emergencies between the City of Fernie and the Districts of Sparwood and Elkford. Council endorsed the Mutual Aid Agreement as presented and authorized the Mayor and Corporate Officer to execute the agreement. This agreement provides a mutual benefit to all parties involved and with the continued challenges all Fire Services have in recruiting and retaining auxiliary staff, it will provide all citizens with a better level of response for any large scale responses in the event the municipality does not have the appropriate resources to bring an incident under control <u>Staff Report</u> | <u>Agreement</u>
