




TaxTALK – A Little Bit of History Before we Begin – 2015 Budget Breakdown

TaxTALK - PART 2 Asset Management

With the responsibility of a Municipality to ensure sustainable service delivery to its residents far into the future, long-term Asset Management is an on-going concern. Municipalities strive to provide satisfactory Sustainable Service Delivery by maximizing benefits while minimizing risks and costs to acquire, operate, maintain and replace these assets.

The City of Fernie has an extensive list of infrastructure (assets) including: parks, trails, community facilities, sidewalks, roads, and flood protection works such as dikes, water and sewer mains.

In Fernie, as in many communities across Canada, our infrastructure is aging and requires additional investment to fund a backlog of deferred repairs and construction referred to as Infrastructure Deficit.

Our primary challenge in confronting the Infrastructure Deficit is sourcing sufficient funds to undertake much needed repairs or replacement.
